Release and Waiver of Liability, Assumption of Risk, Indemnity Agreement, and Non-Disclosure Agreement

In consideration of being permitted to participate in the New England Antiquities Research Association (NEARA) Field Trip, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin agree as follows:

1. I acknowledge that I understand that there are risks associated with field trips and that I am in good health and physical condition. If at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the field trip. The risks posed by my participation in NEARA field trips may result in minor injuries, serious injuries, or in extreme circumstances, even death.
2. I understand that the risks associated with exploring lithic structures may be caused by me through my own actions, or inaction, or the actions or inaction of others participating in the field trip and that there may be other risks either not known to me or not readily foreseeable. I fully accept all such risks and responsibility for injury, harm, losses, costs and damages that I may incur as a result of my participation in and travel to and from the field trip.
3. I hereby accept and assume all such risks, and assume all responsibility for the injury, harm, losses, costs and/or damages following such illness, injury, or death, even if caused, in whole or in part, by the negligence of any and all of those involved with the running of the field trip. I agree to indemnify and hold NEARA and its directors and representatives harmless from any and all claims, actions, suits, procedures, and liabilities, including attorney's fees, and to reimburse for any such fees and expenses incurred.
4. I agree not to reveal to anyone the location of the site(s) visited by the field trip. I will not post in any media any information that would allow someone to find the site(s). I will make sure that any photographs I share do not have any geotagged information nor any signs or any other clues about the location.
5. I will not disturb, damage, or destroy any site or any feature at any site.
6. I will respect the wishes of the land owner(s) regarding visitation of their land and behavior on their land.
7. I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely without the inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
